Funding available for clean water projects in Baltimore City communities – your stormwater utilities fees at work!

Baltimore, Maryland – Today, the Chesapeake Bay Trust and the Baltimore City Department of Public Works announce a grant opportunity to fund projects that improve and green communities, reduce polluted runoff, and improve or create local natural resources like green spaces, parks, tree canopy, and more. Funding for projects in the City comes from the stormwater utility fee. The Department of Public Works is committed to bettering the health and well-being of City residents by investing the stormwater utility fees back into the communities it serves.

Eligible projects types include but are not limited to stormwater management education and awareness programs; projects that reach faith based communities, Spanish-speaking communities, and communities identified in Baltimore City's MS4 Watershed Implementation Plan; pet waste removal campaigns; litter reduction campaigns; bioretention cells, bioswales, rain gardens, rain barrels, urban tree canopy projects; and green workforce development such as environmental project maintenance training.

"The Chesapeake Bay Trust is thrilled to continue its partnership with Baltimore City to engage local residents and promote greening of local communities," said Jana Davis, executive director of the Chesapeake Bay Trust. "Such greening improves community livability, walkability, and human health in addition to providing environmental benefits."

"We are making a difference in the City of Baltimore. Residents and organizations can utilize these grants to impact their local neighborhoods while helping to reduce water pollution and create a cleaner, greener, and healthier Baltimore City," commented Rudolph S. Chow, Director of Public Works.

Non-profit organizations, including local watershed groups, community associations, service and civic groups, and faith-based organizations, are eligible and encouraged to apply for funding. As part of an effort to more fully engage underrepresented groups in its grant-making, the Trust strongly encourages projects that increase awareness and participation in multicultural communities. Residents of Baltimore City are invited to participate in a workshop to learn about designing and implementing outreach and restoration projects and how their stormwater utility fees improve local communities and the environment.
