Since its founding in 2021, the company has primarily served commercial clients such as homeowners associations, condominium associations, apartment complexes, office parks, and retail centers. The company operates throughout Maryland, Washington, DC, and Northern Virginia, covering locations within 75 miles of Washington, DC. Depending on project demands, Arborist Associates runs between three to five crews focused on tree work and planting. The business generates annual revenue in the range of \$1 to \$1.5 million.

Lessons from Past Failures

At Lexington Square Condominium in Arlington, VA, trees and shrubs planted in front of the building did not survive due to damage from pet waste. Key lessons learned include:

- Careful selection of planting locations and consideration of potential pet-related damage
- Installation of pet waste–resistant plant species
- Implementation of barrier plants to deter pets
- Use of soil amendments such as gypsum
- Supplemental watering to help leach out urea

Specialties

Arborist Associates LLC specializes in planting within high pedestrian traffic areas, emphasizing logistical planning to ensure the safety of both pedestrians and workers. The company specifies plant materials best suited for urban environments, taking into account maintenance requirements and growth potential. Considerations include potential height and spread, proximity to structures, tree structure for safety, fruit or flowers, allergy potential, wildlife attraction, and environmental cooling benefits.

Method of Evaluation

Plant material recommendations are based on experience from previous plantings, site location, client needs, common insect and disease issues, environmental impact, sustainability, and future maintenance requirements.
