GRANTS: UPCOMING DEADLINES & OPEN PROGRAMS

The Chesapeake Bay Trust's grant-making strategies are shaped by three core objectives: environmental education, demonstration-based restoration, and community engagement. We look to these objectives as basic touchstones for developing our programs, engaging new partners, and communicating about our work.

EPA Goal Implementation Team Project Support: January 22, 2021, at 4PM EST

The EPA Goal Implementation Team Project Support Program is a partnership between the U.S. Environmental Protection Agency (EPA) and the Chesapeake Bay Trust. This program is designed to invite entities experienced in various aspects of fisheries, watershed science and policy, watershed stewardship, outreach and training, climate resilience, submerged aquatic vegetation (sav), and other watershed issues to submit proposals to advance specific outcomes of the 2014 Chesapeake Bay Watershed Agreement.

Restoration Research Grant Program: January 29, 2021, at 4PM EST

The Chesapeake Bay Trust, the Maryland Department of Natural Resources, the National Fish and Wildlife Foundation through the Environmental Protection Agency's Chesapeake Bay Program Office, the Maryland Department of Transportation State Highway Administration, the Montgomery County Department of Environmental Protection, and other partners announce a Request for Proposals for its Restoration Research award program. The goal of this research program is to answer several key restoration questions that are a barrier to watershed restoration project implementation.

<u>Anne Arundel County Watershed Restoration Grant Program</u>: March 4, 2021, at 4pm EST

The Anne Arundel County Watershed Restoration Grant Program is a partnership between the Anne Arundel County Bureau of Watershed Protection and Restoration, the City of Annapolis, and the Chesapeake Bay Trust. This program funds projects to reduce pollutants through the implementation of watershed restoration practices. Projects must accomplish on-the-ground restoration that treats rainwater runoff from impervious surfaces or demonstrates the accomplishment of another metric that will help the County and City meet local water quality and runoff reduction improvement goals.

Chesapeake Conservation Corps Member Application: March 4, 2021, at 4PM EST

The Chesapeake Conservation Corps is a partnership between the Maryland Department of Natural Resources, BGE an Exelon Company, the National Park Service, and the Chesapeake Bay Trust. The Corps is a leadership program that provides young adults (ages 18-25) with hands-on environmental and leadership experience through placements with nonprofit or government agencies for one-year terms of service in the Chesapeake Bay region.

Green Streets, Green Jobs, Green Towns Grant Program: March 4, 2021, at 4PM EST

The Green Streets, Green Jobs, Green Towns Grant Program is a partnership between the U.S. Environmental Protection Agency (EPA), the Maryland Department of Natural Resources, and the Chesapeake Bay Trust. This program is designed to help communities develop and implement plans that reduce stormwater runoff, increase the number and amount of green spaces in urban areas, improve the health of local streams and the Chesapeake Bay, and enhance quality of life and community livability.

<u>Charles County Forestry</u>: Rolling deadline

The Charles County Forestry Grant Program is a partnership between the Charles County Government and the Chesapeake Bay Trust that aims to fund projects to implement cost-effective reforestation projects in the County to increase tree canopy and as a result create forest habitat and improve water quality in the county's local watersheds and ultimately the Chesapeake Bay.

Community Engagement and Restoration Mini Grant Program: Rolling deadline

The Community Engagement and Restoration Mini Grant Program is designed to engage Maryland residents in activities that enhance communities, engage residents, and improve natural resources. This program funds small-scale activities such as tree plantings, rain gardens, stream cleanups, and storm drain stenciling, among others.

Prince George's County Rain Check Rebate: Rolling deadline

The Prince George's County Rain Check Rebate Program offers rebate incentives to homeowners, businesses, and others to install practices that will improve stormwater runoff quality, reduce pollution, and improve local stream and river health. Seven types of stormwater practices are eligible for rebates: rain barrels, cisterns, rain gardens, urban tree canopy, pavement removal, permeable pavement, and green roofs.

Sponsorship Program: Rolling Deadline

The Sponsorship Program is designed to support events that will increase awareness and knowledge among event participants about issues pertaining to restoration and protection of the natural resources of the Chesapeake and/or Maryland's other watersheds. The Trust will also entertain requests that promote the following major sources of revenue for the Trust: 1) the "Treasure the Chesapeake" license plate program; 2) the Chesapeake and Endangered Species Tax Check-off on the Maryland State income tax form; and 3) the Maryland Outdoor Recreation and Clean Water Fund.

Now in its 5th year, the Best Urban BMP in the Bay Awards contest (BUBBAs) recognizes the best practices and programs being implemented in the urban environment across the Chesapeake Bay watershed. The BUBBAs shine a light on local innovators using creative approaches to protect and restore local watersheds.

The goal of the BUBBAs is three-fold:

- 1) Recognize innovators in the field who are using new and creative techniques to treat runoff and protect streams;
- 2) Share these innovative techniques with other communities who could benefit from the lessons learned; and
- 3) Inspire interaction among our 11,000+ member network of stormwater professionals throughout the Bay watershed and beyond.
