NOTICE: n keeping with FY26 budget prioritizations the Rain Check Rebate Program, Stormwater Stewardship Grant Program, and Community Gardens Mini Grant Program are proposed to be suspended for FY26, July 1, 2025 – June 31, 2026

Active Rain Check Rebate applications and projects must be completed with all materials submitted by May 1, 2025, to qualify for the rebate. Applications for Rain Check Rebates closed on April 5, 2025, in anticipation of the proposed suspension.

Gardens Mini Grant Program projects will continue.

We continue to recognize the positive benefits and environmental uplift of these projects. In addition, we recognize that the programs and their projects provide opportunities to County property owners and communities. Should the proposed suspension occur, we will re-evaluate the potential reinstatement of these programs as soon as feasible.

<u>Anacostia Watershed Society's Mussel Power: Empowering High School</u> <u>Students as Environmental Stewards</u>





Through the <u>Prince George's County Stormwater Stewardship Grant Program</u>, the Anacostia Watershed Society was able to engage teachers and students in raising native freshwater mussels and their importance to water quality.

For the past four years, the Anacostia Watershed Society (AWS) and Prince George's County Public Schools (PGCPS) have been implementing the Mussel Power program together, engaging PGCPS high school students. The Mussel Power program is a multi-part program that includes professional development workshops for teachers, introductory classroom work for students, a field study on the Anacostia River, follow-up classroom work, and participation in an authentic mussel restoration project. Additionally, AWS and PGCPS have

collaborated to enhance the professional development component of the program for teachers to include biweekly Zoom meetings to establish and strengthen a professional learning community of teachers who can learn from each other's challenges and successes and fine-tune their program delivery.

In addition to the professional development for teachers and subsequent classroom lessons facilitated by teachers, the program also includes field experiences at Bladensburg Waterfront Park and on the Anacostia River. These field experiences allow students to not only have a fun and engaging experience out in their local environment, but also to gain exposure to natural resource management careers and restoration projects. The ultimate goal of this program is to inspire not just the next generation of environmental professionals, but the next generation of environmental stewards who are empowered with the knowledge and understanding of how science impacts our daily lives.

Fort Washington Resident Receives a \$100 Rebate for Installing a Rain Barrel at Their Residential Property



The <u>Rain Check Rebate Program</u> supports eight eligible practices, including rain barrels and cisterns. Rain barrels are containers used to collect and temporarily

store rainwater that flows from the rooftop. Cisterns are essentially larger versions of rain barrels that store a lot more water.

Collected water can be reused for non-potable purposes, such as watering your flower garden, trees, or lawn! It's a great way to reuse water that otherwise might run off into your local waterways during a large storm event.

Prince George's County Community Gardens Mini Grant Program



The Prince George's County Community Gardens Mini Grant Program supports the creation and need for community gardens that provide resources to the Prince George's County community while advancing the Prince George's County Climate Action Plan. The primary goal of this mini grant is to fund community garden projects that help address food security and support neighborhood scale implementation of regenerative agriculture and other sustainable gardening practices.

This program supports both the development of new community gardens as well as the growth of existing community gardens that plan to expand regenerative practices. New community gardens can request up to \$9,500. Existing community gardens can request up to \$3,000 OR \$9,500 with the addition of mentorship. Mentorship can include, but is not limited to, mentoring applicants applying for community gardens, holding classes and information sessions, and conducting tours.

This program is currently closed. In keeping with FY26 budget prioritizations the Rain Check Rebate Program, Stormwater Stewardship Grant Program, and Community Gardens Mini Grant Program are proposed to be suspended for FY26, July 1, 2025 – June 31, 2026. Active awarded Community Gardens Mini Grant Program projects will continue.

Maintenance Support Available for Rain Check Rebate Participants



Have you had a stormwater practice installed through the Prince George's County Rain Check Rebate Program? Introducing the Maintaining Stormwater Practices in the Anacostia Watershed program! This program is funded by the National Fish & Wildlife Foundation to help support residential property owners with maintenance of their Rain Check Rebate projects. This program offers support for Anacostia watershed residents through:

- Free Inspections: A landscape professional will evaluate your stormwater practice and provide a written report of maintenance recommendations
- <u>Discounted Maintenance</u>: For a limited time only, get up to 75% of the cost covered for the maintenance of your green feature while you learn proper maintenance techniques through hands-on preparation
- Stormwater Maintenance Resource Center: Check out the online maintenance resources for more information about caring for your stormwater practices
- Green Ambassadors Program (GAP): Are you interested in joining a community volunteer maintenance team to maintain neighborhood stormwater practices, including yours?






THE CHESAPEAKE BAY TRUST, a grantmaking nonprofit, empowers local groups with the resources they need to take on a meaningful and measurable role in restoring forests, streams, rivers, bays, wildlife, and more in their own communities. Every year, about 400 groups receive grant awards or other assistance to accomplish environmental education, community outreach, and local watershed restoration projects. Since 1985, the Trust has awarded \$140 million in grants and engaged hundreds of thousands of resident stewards in projects that have a measurable impact. The Trust has received the highest rating from Charity Navigator for over two decades: on average 90 percent of the Trust's expenditures are directed to its restoration and education programs.
