Important: To be eligible for a reimbursement, all approved practices must have been installed after July 1, 2019, and must be installed before applying to the program. Eligible applications include residential, nonprofit, and commercial properties, as well as condominium and homeowner's associations applying on behalf of more than one property. This program will provide up to 50% match reimbursements for eligible flood mitigation practices. Eligible properties can receive up to a lifetime total of **\$5,000** per property in reimbursements.
